- Requisition Limit Increase

FOR CONSIDERATION

- Regional Parks
 - Adding \$183,000 annually to Parks Acquisition
 - Adding \$18,000 to reserve for KGP
 - Adding \$23,350 for all other parks
 - Need to increase to adequately fund asset renewals
