We recommend you keep a copy of the completed application and receipt for your records, as documentation provided to the qRD will not be returned. The qRD will issue a rebate cheque within 5-6 weeks of receiving proof that program requirements have been met, that the new heating appliance has been properly installed and certified (if required), and that any old wood burning appliance that is being removed has been rendered unusable and has been recycled.

Households that have an EPA/CSA approved wood stove can apply for a heat pump rebate while retaining their wood stove.

#### **Conditions**

- Only one rebate per taxable residence per year.
- A second-hand heating appliance does not qualify as a replacement appliance.
- The value of the rebate must not exceed the value of the new heating appliance.
- Rebate tracking numbers are required and will be issued through the qathet Regional District.
- Both the old wood stove and the new heating appliance must meet the rebate program requirements. For more details visit:

#### To Receive the Rebate:

- The old wood stove must be inspected by a Wood Energy Technical Training (WETT) certified technician to verify the appliance is not up to current EPA certification.
- Residents must verify their wood stove is EPA/CSA certified if applying for a heat pump and opting to keep a wood stove.
- If you are replacing an old wood burning appliance with a new wood burning appliance, the WETT certified technician must certify that the new appliance and chimney meet current WETT and current safety certified standards.

### Step 1: Qualification

To qualify, the appliance being replaced must be:

- Presently used as a primary heating source.
- A non-EPA-certified appliance. (A WETT certified technician such as your retailer or chimney sweep can assist you in verifying that your appliance is non-EPA certified).
- Heat pumps installed in homes with an existing EPA/ CSA wood stove must sign the <u>Clean</u> <u>Burning Pledge form</u> included in this application. Other applicants are not required to do so.

### **Step 2: Application Process**

This brochure is the application form and must be completed in full. Brochures are available at local retailers and at the **qathet Regional District office**:

Applicants must pre-qualify by email, phone or in person to receive a tracking number.

## Step 3a: Disposal of Old Wood Stove

To improve qathet Regional District air quality, to prevent old wood stoves from being reused by someone else and to ensure proper recycling, old wood stoves must be permanently disabled and can be dropped off at a local recycling centre.

We require the signature of an attendant or WETT certified technician to verify the following:

- ☐ Doors removed and door hinges bludgeoned
- ☐ Ash and brick liner removed
- ☐ Flue collar bludgeoned

**Note:** You are responsible for obtaining the appropriate building permit required for installation of a new wood burning appliance.

We require the signature of a WETT certified technician to verify that the old wood stove is **not** up to current EPA certification.

## Step 3b: Verification of EPA/CSA Wood Stove

Residents applying for the heat pump rebate <u>and</u> opting to keep their existing EPA/CSA approved wood stove must verify (i.e. photograph, record model/make, receipts or other documentation, etc.) that the old stove in use is eligible (EPA or CSA certified).

\*The year purchased or installed must be later than 2015.

## **Step 4: Submit Application including:**

☐ A copy of heating appliance purchase **receipt** 

☐ A copy of WETT **inspection report**, if applicable

☐ Both pages of this **application** completed

☐ A **photo** of the old wood burning appliance installed in the home

☐ A **photo** of the new properly installed appliance OR remaining EPA/CSA wood stove if adding a heat pump

☐ Signed Clean Burning Practices Pledge ONLY if following Step 3b

☐ **Signature** of applicant below, verifying completion of online ~1 hour **Wood Smoke Education Course**

- 1. I will only use the wood stove under specific conditions (i.e., power outage and/or during extremely cold weather when supplementary heat is required)
